

PREQUALIFICATION APPLICATION AND QUESTIONNAIRE PACKET

INSTRUCTIONS AND APPEAL PROCESS

I. OVERVIEW

California Public Contract Code ("PCC") section 20111.6 requires <u>all prime contractors</u> with an A or B license and all contractors with M/E/P licenses to be prequalified, before bidding on public projects let by school districts if certain criteria are met. In particular, prequalification is required for contracts valued at \$1 million or more, and that are funded in whole or in part with Leroy F. Greene School Facilities Act of 1998 or any funds from any future state school bond; and it is required for all lease-leaseback contracts. PCC section 20111.6 applies to contractors with the following license numbers ("Contractors"):

- Prime contractors with either an A or B license.
- Contractors with a C-4, C-7, C-10, C-16, C-20, C-34, C-36, C-38, C-42, C-43, or C-46 license, regardless of whether they are a prime contractor or subcontractor.

Contractors must be registered with the Department of Industrial Relations pursuant to California Labor Code section 1725.5 before submitting a bid or being listed as a subcontractor on a bid for a public works project.

II. GENERAL INSTRUCTIONS

This application must be used when a Contractor is seeking prequalification (a) for a particular Eureka City School ("District") construction contract prior to bidding, or (b) through the District's quarterly prequalification process.

It is mandatory that all Contractors who intend to submit a bid for a District public works project fully complete the prequalification questionnaire, provide all materials requested herein, and be approved by the District. If two or more business entities submit a bid on a project as a Joint Venture, or expect to submit a bid as part of a Joint Venture, each entity within the Joint Venture must be separately prequalified to bid.

As projects become available for bidding, Contractors with current and valid prequalification status may receive advance notice from the District.

The prequalification application should be submitted under seal and marked "CONFIDENTIAL" to Eureka City Schools, 2100 J Street, Eureka, California 95501. For a particular contract where prequalification is required, the completed prequalification application must be submitted at least ten (10) business days before the bid opening or deadline to submit proposals, unless the bid package or request for proposals for that contract requires submittal by an earlier deadline. For the quarterly prequalification process, the deadline for submitting a completed prequalification application is twenty-one (21) calendar days before the effective date for that quarter (either March 15, June 15, September 15, or December 15). If a contractor fails to submit an application for that quarterly prequalification process, it may still submit a prequalification application for a particular contract that is advertised for bidding or proposals (see above).

For a prequalification process for a particular project, approval will remain valid for one (1) year from the date of notice of qualification. Under a quarterly prequalification process, approval will remain valid for one (1) year from the effective date of qualification for that quarter (see above). The District reserves the right during that year to adjust, increase, limit, suspend, or rescind the prequalification ratings after giving notice of the proposed action to the Contractor, and an opportunity for a hearing consistent with the hearing procedures described below for appealing a prequalification determination. The District will maintain a list of all prequalified contractors that will include the expiration dates of the contractors' prequalification. The District will make this list available upon request. In addition, the District will distribute the list to all bidders on a contract at least five business days prior to the bid or proposal deadline for that contract (per Public Contract Code §20111.6(j)).

Pursuant to Public Contract Code section 20111.6(b), the prequalification packages (questionnaire answers and financial statements) submitted by Contractors are not public records and are not open to public inspection. All information provided will be kept confidential to the extent permitted by law, although the contents may be disclosed to third parties for the purpose of verification, investigation of substantial allegations, and in the process of an appeal hearing. However, the names of Contractors applying for prequalification status shall be public records subject to disclosure pursuant to the California Public Records Act, and the first page of the questionnaire will be used for that purpose.

III. COMPLETING THE PREQUALIFICATION PACKAGE

Answers to questions contained in the attached questionnaire, information about current bonding capacity on an aggregate and per project limit, notarized statement from surety, and the most recent reviewed or audited financial statements, with accompanying notes and supplemental information, are required. The District will use these documents as the basis of rating contractors in respect to the size and scope of contracts on which they may bid or subcontracts that they may enter with a bidder; the District reserves the right to check other sources available. The District's decision will be based on objective evaluation criteria.

While it is the intent of the prequalification questionnaire and documents required therewith to assist the District in determining Contractor responsibility prior to the submission of bids and to aid the District in selecting the lowest responsible bidder, neither the fact of prequalification, nor any prequalification rating, will preclude the District from a post-bid consideration and determination on a specific project of whether a Contractor has the quality, fitness, capacity, and experience to satisfactorily perform the proposed work, and has demonstrated the requisite trustworthiness. Contractors are encouraged to submit prequalification packages as soon as possible, so that they may be notified of prequalification status well in advance of upcoming projects.

Each questionnaire must be signed under penalty of perjury in the manner designated at the end of the form, by an individual who has the legal authority to bind the Contractor on whose behalf that person is signing. If any information provided by a Contractor becomes inaccurate, the Contractor must immediately notify the District and provide updated accurate information in writing, under penalty of perjury.

The District reserves the right to waive minor irregularities and omissions in the information contained in the prequalification application submitted, to make all final determinations, and to determine at any time that the prequalification procedures will not be applied to a future public works project.

IV. APPEAL OF PREQUALIFICATION DETERMINATION

A Contractor who has submitted a completed application form, and who receives a rating of "not qualified" from the District, may appeal that determination. There is no appeal from a finding that a Contractor is not prequalified because of a failure to submit required information, but reapplication during a subsequent prequalification period is permitted. A Contractor may appeal the District's decision with respect to its request for prequalification, and request a hearing, by giving notice to the District no later than five (5) business days after receipt of notice of its qualification status. Unless a Contractor files a timely appeal, the Contractor waives any and all rights to challenge the qualification decision of the District, whether by administrative process, judicial process, or any other legal process or proceeding.

If the Contractor gives the required notice of appeal and requests a hearing, the hearing shall be conducted so that it is concluded no later than five (5) business days after the District's receipt of its Notice of Appeal. The hearing so provided shall be an informal process conducted by a panel to whom the Board of Trustees of the District has delegated responsibility to hear such appeals ("Appeals Panel"). At or prior to the hearing, the Contractor will be advised of the basis for the District's prequalification determination. The Contractor will be given the opportunity to present information and present reasons in opposition to the prequalification determination. At the conclusion of the hearing or no later than one (1) day after completion of the hearing, the Appeals Panel will render its decision. The date for submission and opening of bids for a specific project will not be delayed or postponed to allow for completion of an appeal process.

A contractor seeking to invoke this exemption shall submit the enclosed Small Business Declaration form. As of January 1, 2019, the qualifying amount is \$15 million, and 25 percent of that amount is \$3.75 million.

^{**} An additional notarized statement from the surety may be requested by Eureka City Schools at the time of submission of a bid, if this pre-qualification questionnaire is submitted more than 60 days prior to submission of the bid.
